Exhibit D DISCLOSURE FORM FOR LOANS OR GIFTS TO PLAYERS

INSTRUCTIONS

Section 5(B)(5)(a) of the MLBPA's Agent Regulations prohibit Player Agents and Applicants for certification from providing any gifts or loans of money or any other thing of value with an aggregate value exceeding \$500.00 in any calendar year to any professional or amateur player, or his relatives or associates, <u>unless</u> the Player Agent or Applicant represents that player, the purpose and terms of each gift or loan are disclosed in writing to the MLBPA, and the MLBPA does not determine that the gift or loan is prohibited.

In 2013, the Agent Regulations were amended to require the Players Association's <u>prior</u> written approval before lending money to a player.

An Agent may submit a request to make a loan to a player by sending

an email to **rguerra@mlbpa.org** with a cc to **agent.reg@mlbpa.org**. To ensure a quick determination of your request, please include information concerning the purpose for the loan, the terms of the loan, how long you have represented this player, and a copy of the Player Agent designation form.

Gifts should be disclosed <u>prior</u> to being made, if practicable, or as soon thereafter but no more than 48 hours thereafter.

Use this form to disclose any loans or gifts exceeding \$500.00 in the aggregate during this calendar year which you, the agency you represent, or anyone else on your behalf, intends to make (or has made) to any player you represent, or any of his relatives or associates.
